SAVE International Copyright Assignment Agreement

By executing this copyright assignment agreement, copyright of the work is hereby irrevocably assigned to SAVE International in return for publication and distribution of the work in a SAVE International journal, magazine, newsletter, or other media, subject to the rights below reserved by the author and/or employer. SAVE International shall have the sole rights of distribution or publication of the work in all forms and media, or by any means, now known or later developed.

The author agrees to deliver the work in a form satisfactory to the publisher (at the publisher’s sole discretion) according to the author guidelines and no later than the submittal deadline specified above or six weeks prior to the press date specified above, whichever comes first.

The author is under no obligation to create new versions and/or derivative works unless otherwise agreed upon in writing with the publisher.

The publisher retains authority to modify the work, at its sole discretion, to correct any errors or deficiencies or to improve the marketability of the work. The publisher will submit such modifications to the author for review and approval before the press date.

The author further agrees to make any necessary modifications which the publisher believes is necessary to correct any deficiencies in or to improve the marketability of the work. The author agrees to review, revise, and return the work with his or her approval to the publisher before the press date.

Should the author object to the publisher’s recommended modifications, the author may withdraw the work from the publisher’s consideration. Written notice of the work’s withdrawal from consideration must be received in writing by the SAVE International Business Office before the press date. Upon

withdrawal of the work in accordance with this agreement, all rights to the work will revert to the author.

If the publisher does not receive the author's revised work or the author's written notice of withdrawal before the press date, the publisher may publish the article as modified by the publisher or reject the article for publication. Should the publisher decide not to publish the work after initial acceptance, written notice will be mailed to the author prior to the press date, with all rights reverting to the author.

The author shall receive no monetary payment in return for publication of the work by SAVE International. The publisher shall grant the author full credit for the article's content via a byline.

The author warrants:

- The work is original and that the author is the sole owner thereof and has the right to execute the agreement.
- The work is not in the public domain.
- Neither the work nor portions of the work have been published elsewhere in any form except as a preprint. If this is not the case, SAVE International must be notified and appropriate credits and permissions to republish must be attached to this copyright assignment agreement.
- The work does not infringe upon the copyright of others.

Non-disclosure of propriety information:

- The author warrants that he or she will not disclose, use, modify, copy, or reproduce the work or any portion thereof, except in accordance with this agreement or after first obtaining written permission of the publisher.
- The author specifically agrees to prevent the author's employees, agents, attorneys, and representatives from disclosing such proprietary information and shall hold the publisher harmless and protect and indemnify same in event of any disclosure by said persons.

The author and publisher agree to abide by the terms of this copyright assignment agreement. If the work is the creation of multiple authors and if each author's signature does not appear below, then the signing author represents that he or she is authorized to execute this agreement for and on behalf of all the authors of the work.
